

DEPARTMENT OF MOTOR VEHICLES COURT CODE NUMBERS

DMV Court codes have special significance. Court code numbers are systematically assigned to denote the county and level of court. The first two digits identify the county. The third digit identifies the type of court. The final two digits are the sequential numbers for the court in that county. For example:

01100

- First two digits = 01 (Alameda County)
- Third digit = 1 (Superior Court)
- Final two digits = 00 (First in sequence for Alameda County)

*Reference for the third digit:

- 1, 4 or 6 denote Superior Courts
- 2 denotes Juvenile Courts
- 8 or 9 denote U.S. District / Magistrate / Federal

Note: 3, 5 and 7 are designated for agencies not listed in this directory.
